For the nine months ended 31st December, 2013, Speciality Restaurants Ltd. recorded revenue of Rs. 19,635 lakhs as against Rs. 16,847 lakhs, amounting to an increase of 16.5%; while Profit After Tax touched Rs. 1,546 lakhs as against Rs. 1,807 lakhs.
