

Calcutta and Sigree-Global Grill as its key brands reported a Total Income from Operations of Rs. 7,695 lakhs for Q4 FY16 as against Rs. 7,361 lakhs in the corresponding quarter of the last year thus marking a growth of 4.5% on a y-o-y basis. EBIDTA and Profit after Tax for Q4 FY16 was reported at Rs. 3 lakhs and Rs. (403) lakhs respectively.

As on 31<sup>st</sup> March, 2016, the Company had a total of 105 Restaurants (including 22 franchisees) and 18 Confectionary stores across 22 cities in India, 1 in Bangladesh and 1 in Tanzania. During the quarter ended 31<sup>st</sup> March, 2016 the Company opened 5 restaurants (Zoodles - 1 No, Café Mezzuna - 2 No, Hoppipola - 2 No) and closed three restaurants (Mainland China - 2 No. and Machaan - 1 No.) and one confectionary store.
